United 896 OXY BLUE is a specialized formula of potassium permanganate that is fed into the system by slow release. The product is suspended into the flow in a polyester mesh bag.

BENEFITS:

- \bullet Effective on $\mathsf{H}_2\mathsf{S},$ mercaptans and other noxious odor compounds.
- Prevents sulfide-based corrosion.
- Treats locations that lack adequate utilities.
- Simple to feed—no pumps or other mechanical devices are needed.
- Eliminates the health risks associated with H₂S exposure.
- Long-lasting. Requires minimal manpower.

DIRECTIONS FOR USE:

With flow rates of 50,000 gallons per day or less, an initial dose of 20 pounds is recommended.

With higher flow rates, an initial dose of 40 pounds is recommended.

The amount of product fed into the system can be controlled by adjusting the amount of the bag that is submerged in the water.

In some applications, a crust can form on the submerged **OXY BLUE**. If this happens, simply shake the bag vigorously to break the crust.

In cases where the H_2S levels are excessive, pretreat the system with a slug dose of **OXY BLUE**. Drop individual tablets into the system. They'll dissolve slowly as they bounce downstream.
