#### DIRECTIONS FOR USE:

Always handle this product with care.

When possible, block section of line to be treated to insure prolonged contact. Sewer balls or other non-organic flow restricting devices will work well for this application.

Pour **United 999 LINE MINER** directly in manhole upstream, above area to be treated. **LINE MINER** will float downstream to obstruction. To activate product and to help generate foam, add water pressure behind product.

Use the appropriate amount of **LINE MINER** to treat the length and diameter of the sewer line as follows:

Diameter of Sewer Pipe	8 in.	10 in.	12 in.	20 in.
One gal. treats...	750 ft. of Sewer Line	600 ft. of Sewer Line	500 ft. of Sewer Line	300 ft. of Sewer Line

Lines may contain other organic debris that are causing obstructions and preventing **LINE MINER** from working properly. Ask your United representative about our other sewer line products. Never use this product directly in conjunction with another product.
